and that they submit this affidavit to Mount Clemens Community School District, in support of a request to enroll their student(s) in the school district. The applicant understands that under state law a school district is not required to enroll a student who has been expelled from another school district, and they understand that students expelled from other public schools for the offenses mentioned below are not permitted to enroll in the Mount Clemens Community School District. The applicant says that they have personal knowledge that the student they are enrolling has not been expelled for any of the offenses listed below, and that such student has not voluntarily withdrawn from any school district in order to avoid being expelled:

- (a.) Use or possession of any dangerous weapon,
- (b.) Commission of any act of arson in a school building or on school grounds,
- (c.) Commission of any criminal sexual conduct in a school building or on school grounds,
- (d.) Commission of any verbal assault or any physical assault at school by any pupil enrolled in grade 6 or above, against another pupil, or against any person employed by or engaged as a volunteer or contractor by the school board,
- (e.) Threatening to set off an explosive device or other dangerous device on school premises, in a school related vehicle, or at a school sponsored activity or trip, or making a threat of danger that causes an evacuation of a building or event,
- (f.) Expelled from any school district, in Michigan or any other state, for any reason during the preceding two years.

Mount Clemens Community Schools will request the student's former school district to supply information and records needed by the district for evaluating the applicant's application for enrollment. Mount Clemens may make enrollment decisions based on the information provided by the applicant in the application for enrollment pending receipt of the official record from the student's former school.

*If the student's records shows that the student has been expelled for such any offense, or has voluntarily withdrawn from any school district in order to avoid any such expulsion, or that the applicant has negligently or intentionally made any false or misleading statement, about the student concerning any of the above mentioned offenses, in order to induce the District to enroll the student, then such admission and enrollment in the Mount Clemens School District shall be revoked, annulled and rescinded, and the student shall not be allowed to continue enrollment at Mount Clemens Schools.*
